HIPAA certification is akin to an internal audit of policies, procedures, documentation, and security controls, which is a requirement of the HIPAA Security Rule. Section 45 CFR § 164.308 (a) (8) of the Administrative Safeguards of the HIPAA Security Rule requires HIPAA-covered entities to periodically evaluate their compliance program.
